128th ANNUAL MEETING MINUTES

Barbara Deedler, Church Clerk

Minutes of the 128th Annual Meeting The Community Church of Sebastopol January 28, 2018

The meeting was called to order by Patty Raney.

Pastor Benjamin led an opening prayer. He then commemorated with a prayer and a soft bell tone members and friends who passed on in 2017. They were: Jean Anderson, Elaine Bornman, Donna Crosley, Sharon Elder, Louise Hallberg, Bob Harper, Dick Huppertz, Mac MacDonald, Ken McHugh, Kathie Noguchi, Dorothea Rowden, Bill Stillman, Donna Tappan.

The minutes of the 127th annual meeting were approved.

The annual reports were presented and approved.

2017 Financial Report and Proposed 2018 Budget:

John Henel and Dan Rasmus reviewed the 2017 financial report and the proposed 2018 budget.

They did a recap of 2017, explaining that we ended with a surplus of \$21,383. This was moved to the Reserve Fund which now has a balance of \$55,000.

John then reviewed the proposed budget for 2018. He thanked the budget committee, Kathy Bell, Ben Broadbent, Lisa Dawson, John Henel, and Dan Rasmus. They started in September and met every two weeks, gathering input from all committee chairs. The proposed budget was approved by Trustees and Council.

He explained that the budget is an expression of our goals and values, and of our ministry to each other and the wider community. The Annual Appeal was successful with 139 household pledging and pledges to our wider mission were up 10%. \$9,000 was needed to balance the budget and will be taken from the Reserve Fund as needed. He also added that Ann Butterfield was hired as an internal auditor, and that she has helped to streamline their processes. An Interfund Transfer Account has been started to track funds transferred from restricted accounts.

He then answered questions and addressed concerns.

M/S/P Jeff Boal / Judy Peterson to approve the 2018 Operating Budget for the Community Church of Sebastopol.

Presentation of the New Governance Structure and Bylaws Revision: the Governance Committee presented and explained the planned changes in our governance model and proposed Bylaw changes to support this. It was explained that there would be no voting on this today. Copies of the revised Bylaws and a diagram of the model were distributed.

Judy Rice presented an overview of the process this past year. The book, Governance and Ministry: Rethinking Board Leadership, by Dan Hotchkiss, was used as a reference. A Governance Sub-Committee was formed (Patty Raney, Judy Rice, Benjamin Broadbent, Chris Dawson, Marge Holland and Michael Ott.). This has been an ongoing process with multiple

meetings, a leadership retreat, etc. On September 6 the governance model was presented to the Trustees and on Sept. 10, Patty Raney announced the proposed governance change process to the Congregation on Launch Sunday. All were invited to participate, discuss and give feedback. A By-laws sub-committee was formed and they have met several times in the past weeks. The revised Bylaws support the new governance model.

Micheal Ott presented an overview of the proposed model. Using the Governance Model diagram, he explained the four ministry areas, the three support areas, and the 8 member Leadership Council. These Council members would be nominated by the Nominating Committee and elected by the Congregation. This presents a smaller, more nimble and dynamic Council.

Nancy Shimetz explained the next steps. She stated "the process is not over yet" and reviewed the proposed next steps. Several more feedback sessions are planned, and the congregation is invited to contact any committee member with ideas or concerns about the process or the new by-laws.

A special meeting of the Congregation will take place on April 15 to consider with an "up or down" motion to adopt the proposed revision of the Bylaws. If the motion passes, the Nominating Committee will have a prepared slate of nominees for new Council positions for approval.

Nominating Committee Report: The following changes were made to the report: Add Judy Rice to Trustees and Patty Foster to the Youth Committee. Laurie Mitchell is not on the Visitation Ministry Committee.

M/S/P Kathy Bell / Pat Furber to accept the report of the Nominating Committee with the above changes.

Acknowledgement of Leaders for 2017: Pastor Benjamin recognized the leaders for 2017. Barbara Deedler was acknowledged for 29 years as Clerk.

Acknowledgement of Leaders for 2018: Pastor Benjamin recognized the leaders for 2018. **Acknowledgement of Patty Raney:** Pastor Ben acknowledged Patty for her leadership as moderator during 2017 and presented her with a gift of appreciation. Rachel Knuth led the benediction and the meeting was adjourned.

Special Meeting of the Congregation

April 15, 2018

The meeting was called to order by Moderator, Nancy Shimetz at 11:53 am. The purpose of the meeting was to approve the proposed revised Bylaws.

Ballots were collected and counted. The motion was passed unanimously.

Special Meeting of the Congregation October 7, 2018

The meeting was called to order by Moderator, Nancy Shimetz at 12:06 pm. In accordance with the Bylaws, the meeting was called to share information about the proposal to call an Associate Minister for Faith Formation.

Pastor Ben opened the meeting with a prayer.

Nancy explained that the Leadership Council is poised to move forward with forming an Associate Minister Search Committee yet we feel strongly the need to engage with the congregation in good faith and transparency. The Clerk affirmed that there was a quorum of members present and ballots were distributed to all present.

Linda Inman presented background on how the proposal came about and the reasoning behind it. The resignation of Ross Galetto and Rachel's desire to cut back on her hours were factors.

Rachel spoke of her decision to step away from her current duties and schedule. She explained that due to family responsibilities, she's not able to commit to full time. Her hope is to start as Associate Minister for Pastoral Care in February. This position will work well with her family life and schedule.

The floor was then opened to questions and comments. Some of the concerns were: upcoming financial needs for facilities, the church's ability to afford a full-time position, and whether our funds might be better spent on outreach. There were comments in favor of wanting a position that supports the youth program, which has struggled in the last few years.

After the open discussion, members were encouraged to vote in favor or against the proposal to form a search committee. The results of the poll were 49 members were in favor and 3 were against.

The meeting ended with a prayer and blessing by Pastor Ben.

What Other Time?

When I think back on 2018, these words of theologian Karl Barth resonate: "What other time or season can or will the church ever have but that of Advent?" To me, this means that, as the church, we live in the afterglow of Christ's birth, death, and resurrection, but we also live in anticipation of Christ's return, the consummation of all things, of which we are a part but not in charge. All things – birth, life, death, rebirth – belong to God. Our role is simply to respond, with daring faith and audacious hope, grateful that God is God and we are not.

Special Items:

- Rev. Gene Nelson, retiring in 2016 after 38 years as our Senior Minister, was approved
 for the title of Pastor Emeritus. The title was officially bestowed on him worship on
 October 14th. This was an exciting event and it is good to have him worshiping with us
 again.
- Member Ross Galleto in August was approved and recognized as a Member in Discernment of authorized ministry in the NCCUCC. He is a student at Chicago Theological Seminary and this recognition will help toward his ordination.

Associate Minister for Faith Formation:

Proposal to initiate the search process for a second full-time pastor was introduced. A
lot has transpired. Please refer to the Personnel Report for details.

- Personnel: Long-time Office Manager Karin Seder retired at the end of September, and Council member Becca Emerson was hired to the position. Linda Roa was nominated and accepted the position of Council Member for Worship & Arts. Long-time Custodian Keith Blackstone also retired, and Maria Mojica was hired as his replacement.

FACILITIES RESOURCE AREA 2018 REPORT

Larry Stallings, Council Officer for Facilities (Vice Moderator)

The experience and talents of the three facility teams is staggering. The members have brought their professional expertise as a gift to our church community. They are completely integrated which provides mutual support to problem solving. Together, we have discovered some old projects not completed and other needs that were deferred. We assign a project manager to each repair or project to work directly with staff and members that helps avoid delays or deferments. Our challenge is to maintain warm and welcoming meeting spaces to members and our nearby community; ensuring all rooms and halls are clean, well lit, walls are painted and floors maintained in excellent condition. Our primary challenge in 2019 will be to repair the sanctuary support beams and make our campus more sustainable. The structural beam repair project is planned to commence in late spring. We started composting late in 2018 with the goal of increased sustainability and safety. We are currently exploring various options to add solar power to our facilities to reduce our carbon foot print and decrease utility costs.

We are devoted to becoming a place of hospitality and the number one choice to all who need space to sponsor an event or celebration.

Landscaping Team – Larry Stallings, Council Member for Facilities

The year 2018 brought us a leadership change to the group. Barbara Whitson served as the leader for 8 years and passed these duties to Patty and Keenan Foster. Our sincere thanks to Barbara for these dedicated years of service and our appreciation that she will continue as a team member. Her knowledge and experience cannot be replaced. A special thanks is extended to Bob Holland who trims our roses and maintains our campus wide drip system.

The team is comprised of volunteers who meet with Patty and Keenan to cultivate soil, plant and add new features as the recent addition of succulents.

The team also evaluated the landscaping service Community Church contracted with and determined our in-house team was doing 90% of the work. We cancelled the \$8000.00 annual contract and all work will be done by church members who are devoted to our rich natural beauty. New volunteers are welcomed to join our crew.

Facility Committee – Larry Stallings, Council Officer for Facilities 2018 Members – Lisa Dawson & Chris Dawson, co-chairs, Kim Buckman, Judy F

Lisa and Chris will rotate off the committee in early 2019 as they have completed two years of faithful service. The new chairperson will be Judy Peterson. We have also added new members Jane Huneke and Roger Wilson.

Some major tasks completed in 2018 were replacing the shower floors in Memorial Hall, deep cleaning all floors, replacing the water heater in Fellowship Hall, completing the renovation of the Memorial Hall kitchen, tree trimming and starting a composting program. Every week the team completes work orders that are submitted to the church office such as replacing light fixtures, bulbs, repairing fences and doors and installing locks. For 2019 the team has started a structural beam repair project and are exploring options to utilize solar power.

Health & Safety Task Force – Marian McDonald, Health & Safety Task Force Recording Secretary

The Health and Safety Task force was created by the Council on November 1, 2017. First year activities included

• We obtained funding by a grant from our local Rotary club which allowed us to purchase an AED, several first aid kits, and 3 FRS radios.

- We purchased and installed an AED (Automatic External Defibrillator). We are following American Heart Association guidelines for our implementation plan. Training and completion of that plan is progressing. Purchase of a second AED is planned.
- We have bought several First Aid kits to be prominently placed around our premises. We are implementing a plan to keep them stocked.
- We have purchased 3 FRS radios ("walkie-talkies") for use in emergency, also for routine use by staff.
- We have identified the shut-off valves for all utilities and plan documentation for availability in time of emergency.
- Clean-up of the outdoor campus is in progress with the goal of reducing combustible load.
- Improved signage of buildings has been completed as part of our plan for response to an active shooter situation. The lock on the outside door from the Fireside Room has been altered to allow it to serve as an exit.
- We have drafted a policy to require a qualified provider of first aid for all off-site activities.
- We are developing a plan for use of church facilities as emergency community shelter

New to this ministry area in 2018 was the Liturgist Coordinator who recruits and trains lay people to help lead worship. Also new was the art display by Muriel Weaver. We commune by intinction, tearing bread and dipping into a chalice of white juice – we use white juice so as not to stain shirts or blouses or the floor. We sing Taize chants during the time of Communion to maintain a sense of prayerfulness throughout the sacrament.

Thank you to the many people who agreed to serve communion in 2018. Many of you have commented how meaningful it has been to offer the bread and the cup to your fellow worshipers.

"Church Mouse" Ministry – Pastor Benjamin, Lead Minister

Doris Rowe retired from her role as "church mouse" this year. Doris faithfully and diligently spent hours in the sanctuary each week straightening Bibles and hymnals, replenishing offering envelopes and prayer request cards, recycling abandoned bulletins, and sharpening pencils. FAITH FORMATION MINISTRY AREA 2018 REPORT

Linda Inman, Council Member for Faith Formation

Faith Formation, in 2018, was marked by adopting the name of *Faith Formation* to encompass all aspects of Christian Education/Children's Ministry, Youth Ministry, Family Ministry. Undertaking a shift to Faith Formation is more than a name change. It is a challenge and an opportunity to consider more broadly the ways in which our Christian faith may be deepened. Being open to new ways of supporting all people in their journey of faith goes hand-in-hand with the nature of our congregation as an open and welcoming space for people of all, or no, religious background.

As we move forward in this process with excitement, it's important to celebrate the year in review. As you will see in the sections below, 2018 was a busy, engaging and enriching time in our church. None of this would have been possible without the dedicated work of so many people and I invite you to take special note of those who serve among us. Let us give thanks and praise.

Adult Education– Gail Thomas, Adult Education Coordinator

The Adult Education program has been a loose organization of individuals dedicated to various activities supporting Christian Adult Education and in the past year has continued working through email and supporting the passion of each person who wants to present something.

The overall program this year has included a Sunday morning Bible Study class, several different Bible Studies, the Lenten Faith Journey program, and a number of activities by other individuals providing diverse activities such as a Men's Retreat, Women's Retreat, and a "Subversive Advent Study" by Pastor Ben.

This year the Sunday morning program reverted to studying the Bible passage(s) being used in the worship service and then hearing the sermon.

In 2018, the "Faith Journeys" and "Soup Suppers" during Lent again drew exceptionally good attendance and featured some of our newer members, some of our longer-term members, and each with a very different approach to a faith journey. Again, I encourage people to attend for a very special way to get to know your fellow members of our church.

Women's Bible Study– Joanne Matson, Study Facilitator

Women's Bible Study meets on Wednesdays from 10:00 to 11:30 in the Fireside room. Our general study includes both the Old and the New Testament, the extracanonical books and pertinent resource material from scripture scholars, theologians and pastoral commentaries.

We study historical context, cultural background and political settings, attentive to how the original audience heard and understood the Word. Through our study, sharing, and

discussion we continually find new meaning in Scripture enabling us to apply it to contemporary issues and our individual lives.

The Topic for our Winter-Spring 2018 Bible Study was "A Taste of Isaiah" We looked at the Historical background, the message of Isaiah, connecting the dots between the original message and today's worldview.

The focus of the Fall session was Theodicy, the problem of God, Pain and Suffering. Our guide for this study was Barbara Brown Taylor's book, God In Pain and Jesus' life and teachings in the Gospels.

We will continue with this focus for our Winter, 2019 session beginning January 30. 2019.

Children's Faith Formation Action Team (aka CHILFFAT) – Brooke Bell, Team Leader 2018 Members: Brooke Bell, Paula Berndt, Sheina Curtis, Kristen DelMonte, Terri Harper & Leslie Wood

- Under the leadership of Kristen DelMonte as chair through April and then Brooke Bell, decided on a name change – formerly Christian Education Committee.
- During Faith Formation Hour, 9:00-10:15 on Sunday mornings, worked with Pastor Rachel to support the Godly Play Program, a Montessori-based storytelling and art-response program for children in Preschool 5th Grade.
- During worship on Sundays other than the first Sunday of the month, worked with Pastor Rachel to support Children's Worship in Faith Chapel for children in Preschool – 5th Grade.
- Offered our second facilitator training for Our Whole Lives: Sexuality and Our Faith (OWL) in July with 20 participants from churches across the state and programs this fall for two age groups:
 - 1.) Kindergarten & First Grade (Brooke Bell & Pete Emerson, facilitators) with 9 participants, and

- With Pastor Rachel, supported annual MADD Camp (Music, Arts, Dance & Drama) in June.
- With Pastor Rachel, co-created the annual Advent workshop in November with 30 participants and the Advent Spiral.
- Held a mini retreat in October, facilitated by Pastor Benjamin, to discern a Children's Ministry Mission Statement, list of ministry values, and 1 and 3 year goals.
- Brooke, Paula Sheina, Kristen & Terri will continue and new members will be added.

Youth Ministry Team- Debbie McCallum, Team Leader

OUTREACH MINISTRY AREA 2018 REPORT

Michael Ott, Council Member for Outreach

As Leadership Council Member for Outreach, I have been inspired by the work of the various teams and committees under the Outreach banner. The vitality of Outreach ministry and resource areas is robust, leadership is strong and enthusiasm is high. New areas such as the Safe Parking Program have been started, and existing programs such as the Inter-Faith Food Pantry have been greatly expanded.

For 2019, Outreach will strive to be more innovative and try new things. We plan to invite the congregation to increase their part in the work of Outreach at our church and in our community. We plan to continue to provide worthwhile Outreach projects and programs for the congregation. The closing words of our church's Mission statement is "putting our faith into action." That's what Outreach is all about – seeking to join with God to minister, both locally and globally. Please join us!

Mission and Outreach Committee – Michael Ott, Mission and Outreach Committee Chair 2018 Members – Lorinda Bradley, Joyce Cox, Daphne Cripps, Kathy Manchester, Diane McPherson, Susan Nestor, Michael Ott, Laura Pearsall, Peggy Porter and Ellen Stillman.

The Mission and Outreach Committee distributed funds exceeding \$4,700 – funds provided to the Committee from the congregation's pledged Mission Giving. Funds were distributed to the following organizations:

- In response to Erin Butterfield's inspiring presentation about her Peace Corps work in Zambia at Community Church this spring, the Committee donated \$500 to her village in Zambia for the purchase of one electronic sewing machine and one foot-operated sewing machine.
- The Committee donated \$1,200 to New Vision UCC Church in Chico in the fall for fire victim relief in Butte County.
- Seeds of Learning received \$750 from the Committee. Seeds of Learning is a non-profit organization dedicated to improve educational opportunities in rural Latin America.
- The Committee donated \$500 to the Sebastopol Senior Center to be used for their new flooring project.
- The Living Room in Santa Rosa received \$750 from the Committee. The Living Room provides services for women and their children who are at risk and/or homeless. The Living

- Room welcomes homeless and at-risk women and their children into a safe and comfortable environment during the day when shelters are closed.
- The Committee donated \$750.00 to UndocuFund. UndocuFund provides direct funding to undocumented immigrants in Sonoma County and their families to help with temporary housing, home repairs and items, medical and dental expenses, moving and storage expenses and educational materials and supplies.
- Additional gift cards were purchased for the Verity Advent gift card collection.

In May, the Committee organized and participated in a creek cleanup for all ages with Clean River Alliance at Santa Rosa Creek.

Throughout the year the Committee coordinated volunteers who provided bag lunches for the homeless and hungry Monday through Thursday each week at Sebastopol Christian Church.

For the Advent Season, the Committee sponsored the Shoebox Ministry and Gift Card Ministry. The members of the congregation filled the shoeboxes with items suitable for both men and women, wrapped them in Christmas paper, and placed them under the Christmas tree in the narthex. Members of the Committee delivered the gifts to the Homeless Services Center in Santa Rosa. The Gift Cards benefited Verity, a local organization that strives to eliminate all forms of violence, with a special focus on sexual assault and abuse. The gift cards provided to Verity will be handed out by their counselors to sexual assault and abuse survivors who often come to Verity with no possessions and no money as they flee from abuse.

2019 agenda items include a drive for school supplies next fall, continued work with Habitat for Humanity and housing fire clean-up groups at the church.

Faith in Action Team (FIAT) – Joyce Cox, FIAT Coordinator 2018 Members – Joyce Cox, Julie Davis, Judy Davison, Bernie Hovden, Kathy Matthies, Vicky Mayster, and Peggy Porter.

The Faith in Action Team is the coordinating body between the North Bay Organizing Project and the Community Church. In 2018 the three focus areas of the North Bay Organizing Project were Housing and Homeless which has worked a lot on rent control, Immigration - which FIAT has been heavily involved in - and the Environment.

Our Church has hosted several county wide trainings for the Rapid Response Network. The use of our facility has been very much appreciated by a large number of people who have never been here before. Our church has a group of people trained to work as an accompaniment group for individuals or families effected by ICE raids and another group trained to be legal observers during ICE raids. Fortunately, ICE has not been very active in Sonoma County so we are on a holding pattern until needed. There is also a group willing to accompany people to court for immigration hearings or other court proceedings. If you would be interested in helping in any of these areas contact any FIAT member.

In 2018, 11 people spent a week in Lake County working with Hope City to rebuild homes destroyed on the Valley Fire of 2015. Hope City is a small faith-based organization that goes into a disaster area and works for several years building as many homes as possible. They are working to help people in Santa Rosa and Butte County as well. We worked on three homes that were near completion. We shared our housing space with 11 AmeriCorps young adults and 19 youth and adults from a church in Modesto. Kathy Mathies organized food and ran the kitchen feeding us all (including Hope City staff) wonderful food for the entire week. We worked hard and had a productive week!

Alternative Gifts – Joyce Cox, Alternative Gifts Ministry Coordinator

Thank you to everyone who ordered Alternative Gifts this year! Many people around the world will have their lives uplifted thanks to your generosity! People will receive medical treatment, children will be fed, and education and the environment improved! It is amazing that we can make a difference in the world through our giving! We collectively sent \$1,426 dollars to Alternative Gifts International and \$328 to Seeds of Learning for a total of \$1,754! Thank you for your support!

The Community Church in conjunction with the First United Methodist Church of Santa Rosa, Catholic Charities and the County of Sonoma provides four parking spaces in our west parking lot for individuals and families that have no other safe alternatives to spend the night.

Volunteers from our church provide monitoring of the parking lot to make sure the parking participants are safe by driving through the parking lot one time during the night and in the morning. Volunteers are on call if there are any issues. Additional volunteers are always welcome!

Interfaith Food Pantry - Mark and Suzanne Albin, Interfaith Food Pantry Board Members

The Interfaith Food Pantry benefited from the enormous generosity of its supporters in 2018. This increased backing has allowed a number of changes resulting in improved services to the community.

- Food storage capacity was expanded by purchasing and erecting a standalone, ventilated shed.
- The suggested supply list was revamped, nearly doubling the amount of food made available to our customers.
- The foods that the Pantry provides were upgraded, adding cooking oil, cheese, instant potatoes and more fresh fruits and vegetables.
- The wait time for recipients to return for food was reduced from once a month to once every 15 days.
- During the holidays we provided folks in need with vouchers for a free turkey or ham at any grocery outlet in the county.

An exciting new level of responsibility for the Nominating Committee this year. With the adaption of the new church governance structure earlier this year, the nominating committee has under-gone a significant change in responsibility from past practice. FINANCES RESOURCE AREA 2018 REPORT

John Henel, Council Officer for Finance (Treasurer)

First of all, I would like to extend a big thank-you to all who served on committees and teams that assisted in the Finance Resource Area (see names below). Your work is appreciated.

I am happy to report that the church is on solid ground financially. Complete details of all financial data can be found elsewhere in the Annual Report. Here are a few highlights:

- 2018 ended with a \$25,000 surplus in the Operating Fund. This really helps us to maintain the necessary reserves for when all is not going as well, enabling us to maintain more continuity in our ministry.
- At the end of 2018, we held approximately \$550,000 in Endowment Funds. The goal of these investments is to preserve principal while utilizing income and dividends for special projects. Read more in the M&E report below.
- We have no debts.
- Pledges, our primary source of Revenue, for both local and wider church missions are fairly strong. Read more in the G&G report below.
- A general breakdown of expenditures: 70% on Personnel, 15% on Facilities, 7% on Outreach, 4% on Finance, 3% on Faith Formation, 1% Other.

Read more in the section reports that follow for topics in the Finance Resource Area.

Audit - John Henel, Council Officer for Finance

Ann Butterfield, in her role as Internal Auditor, provided valuable support and insight into our financial organization, logging several recommendations to move us towards industry best practices. This was a partial year for Ann in this role, after a change in employment in midyear left her without time to provide this service to the church. However, given the depth of the input she provided, we will not seek a replacement for 2019.

Budget Committee – John Henel, Treasurer

2018 Members: Pastor Ben, Kathy Bell, Larry Stallings, Jennifer Halleck, John Henel

This committee met several times beginning in September to produce the budget for 2019. All functional areas, program areas, and committees are solicited to provide input to the budget for their respective areas. Besides the usual increases in operating costs and personnel expenses, the 2019 Budget had three special challenges:

- The planned addition of a new full-time Associate Minister
- Maintaining Pastor Rachel as she transitions into a new role
- Providing for some significant facilities needs

While all the goals could not be achieved in full, the team was able to come close through a combination of tradeoffs and with the generosity of members of our church. Read more on this in the next section.

Gratitude & Generosity Team (Stewardship) – Rev. Benjamin Broadbent, Lead Minister 2018 Members - Jeff Boal, Lorinda Bradley, Emily Davis, Kristen DelMonte, Keenan Foster, Patty Foster, Bobbie Johanson, Kathy Mayhew, Birgit Quezada, Luis Quezada & Pastor Benjamin

Our G+G Team began meeting in August to plan and execute our Annual Pledge Drive in support of our church's 2019 Local Ministry and Wider Mission Budgets. Keenan Foster assisted with preparing print and digital materials based on our theme, "What Shall We Bring?" We organized the drive into 3 phases:

- 1. Advance Phase In September we gathered pledges from members of the G+G Team, Leadership Council, and our Ministers.
- 2. Public Phase Beginning with the kick off Sunday, October 14, we invited 240 member households to pledge \$369,000 toward our local church ministry and \$41,000 toward our Mission & Outreach. During the public phase, we received stirring testimonies from Michael Ott, Will and Nicole Whitehorn, Terri Harper, and Emily Davis. The public phase ended on Gratitude Sunday, November 11. Birgit & Luis Quezada provided chili for all congregants.
- 3. Follow-Up Phase We followed up with member households from whom we had not yet heard, inviting them to participate in the ministry and mission of the church they love and value. While we did not meet our annual appeal goals, generous pledges helped us get close enough to move forward with most of the Leadership Council's ministry and mission priorities. For 2019, our goals for the G+G Team are: identify a lay person to chair the committee (Pastor Benjamin served in the role this fall); make stewardship a year-round conversation and effort; continue to educate the congregation on how financial giving enables meaningful ministry and mission to occur through our congregation.

Memorial & Endowment Committee – Nathan Knuth, Memorial & Endowment Committee Chair

The Memorial and Endowment Committee began the year hosting the "Let's Make a Plan" education and estate planning seminar event on February 10, 2018. The event drew upon church members to present aspects of financial planning and was well-received.

After the "Let's Make a Plan" financial event, the committee continued the year in a consistent fashion reviewing grant requests and approving grants for church projects that included supporting retreats, organ repairs, and shoring up facilities. Over \$3,000 was granted from Memorial Funds and \$10,000 from the Endowment Fund. Our Endowment investment followed the markets in general, which suffered a fairly negative fourth quarter in 2018. A rebound has already begun in 2019.

Each month the committee went over the monthly financial reports. In June they sought to define the committee's role under the new church government structure adopted in April. To aid our understanding of current practices and procedures, Ann Butterfield (our Internal Auditor at that time) was invited to speak to the committee about the church finance policies and practices. She also shared several articles on policies that other churches had developed to help inform us of possibilities regarding our own practices.

As we began to shape a policy about maintaining reserves, we discovered no template for general church policy was in place. At the suggestion of this committee, a Policy Template was developed by Council, which was approved for general use of the church. In September and October, we discussed and reviewed church policy dealing with reserve monies, how requests were to be made to tap into those reserves, and steps to be followed. This work is ongoing and will be delivered to Council for discussion and approval when completed. The role of the Finance Committee going forward is also under further review and revision.
